The School or School District indicated herein, of Tennessee, hereinafter referred to as "SCHOOL," hereby agrees to participate in a coupon book fundraising program and order and purchase Coupon Books from PRINTVENTURE INCORPORATED, a Tennessee corporation doing business as FEREDONNA COMMUNICATIONS, a wholly owned subsidiary, hereinafter referred to as "FEREDONNA," pursuant to the following terms and conditions:

**I. SCOPE OF PROGRAM** SCHOOL(S) participating in the sale of Coupon Books will receive the following:

1. The number of coupon books ordered packaged 50 books per carton.
2. One program sales brochure per coupon book ordered or participating student enrolled, whichever is less.
3. Staff and student sales incentives.

**II. COUPON BOOK SPECIFICATIONS** Each Coupon Book shall be approximately 2 3/8" x 6" and perfect bound, consisting of a minimum of 480 pages text printed 1 color on offset web paper; and cover printed process four color with UV coating on cover pages 1 and 4 and one color on cover pages 2 and 3 on 8 pt. C1S paper. All text pages will be perforated parallel to the bound edge.

**III. DELIVERY** FEREDONNA will effect delivery of books and any other program material prior to the commencement of the sale to the delivery location specified by the SCHOOL.

**IV. SCHEDULE OF SALE** The SCHOOL will begin selling and/or offering for sale Coupon Books commencing no earlier than September 17, 2009 and continuing through and completing on October 2, 2009. **The SCHOOL acknowledges that no books will be released or offered for sale prior to the commencement date, and that any violation may result in the SCHOOL forfeiting the opportunity to participate in future coupon book fundraising programs.** The parties may elect to extend the selling period by mutual consent. (If SCHOOL desires a later selling period, please contact FEREDONNA before submitting this order.)

**V. PAYMENTS** The SCHOOL agrees to pay to FEREDONNA for each book sold or not returned by the SCHOOL the amount of Three Dollars and Fifty Cents (\$3.50) per book for books ordered and sold totaling less than One Thousand (1,000), and agrees to pay to FEREDONNA for each book sold or not returned by the SCHOOL the amount of Three Dollars (\$3.00) per book for books ordered and sold totaling One Thousand (1,000) or more, and for each book ordered not sold and returned to FEREDONNA in good and salable condition the amount of One Dollar (\$1.00) per book within Ten (10) Days of the completion of the sale as provided for in IV. SCHEDULE OF SALE. FEREDONNA at its sole discretion, may assess a late fee of five percent per month and withhold the award of any earned incentives on any payments not received within fifteen days of the completion of the sale as provided for in IV. SCHEDULE OF SALE. Additional books ordered AFTER commencement of the sale and bound under this agreement, may at FEREDONNA's sole discretion, require an additional payment, if sold, of One Dollar (\$1.00) per book.

**VI. TAXES** It is understood by the Parties that the SCHOOL is exempt from all local and state sales taxes and will provide to FEREDONNA, if required, a certificate of exemption.

**VII. ADDITIONAL TERMS** FEREDONNA may elect to assign any or all of this agreement at its option. Jurisdiction and venue governing this agreement shall properly lie in Knox County, Tennessee. Any cost of collection or enforcement of this agreement may be added to the total amount due and become part of any final judgement. This agreement is binding upon acknowledgment and cannot be cancelled by SCHOOL without prior written consent.

**VIII. ENTIRE AGREEMENT** This agreement constitutes the entire terms and conditions and may only be modified by mutual consent of the parties.
