**I. SCOPE OF PROGRAM** SCHOOL(S) participating in the sale of Save 10 Card™ Discount Cards will receive the following:

1. The number of Discount Cards ordered bulk packaged.
2. Program administration guide.
3. Student sales incentives.

**II. CARD SPECIFICATIONS** Each Discount Card is comprised of one (1) wallet card and one (1) key card affixed to informational card carrier (a sample will be provided upon request) printed process four color two sides on durable 30 mil plastic.

**III. DELIVERY** FEREDONNA will effect delivery of Discount Cards and other program material prior to the commencement of the sale to the delivery location specified by the SCHOOL.

**IV. SCHEDULE OF SALE** The SCHOOL will begin selling and/or offering for sale Discount Cards commencing upon the date specified (upon approval and receipt of program materials) and continuing through and completing upon the date specified (upon approval) or within thirty (30) days, whichever occurs first. The parties may elect to extend the selling period by mutual consent.

**V. PAYMENTS** The SCHOOL agrees to pay to FEREDONNA for each Discount Card sold or not returned in good and salable condition by the SCHOOL as follows:

- On Sales of less than 250 Discount Cards, an amount of Ten Dollars (\$10.00) per Discount Card - 50% Retained Earnings to SCHOOL
- On Sales of 250 to 999 Discount Cards, an amount of Eight Dollars (\$8.00) per Discount Card - 60% Retained Earnings to SCHOOL
- On Sales of 1,000 or more Discount Cards, an amount of Six Dollars (\$6.00) per Discount Card - 70% Retained Earnings to SCHOOL

(unless otherwise noted and approved by FEREDONNA prior to commencement of Sale) within Ten (10) Days of the completion of the sale as provided for in IV. SCHEDULE OF SALE. FEREDONNA at its sole discretion, may access a late fee of five (5) percent per month and withhold the award of any earned incentives on any payments not received within fifteen (15) days of the completion of the sale as provided for in IV. SCHEDULE OF SALE.

**VI. TAXES** It is understood by the Parties that the SCHOOL is exempt from all local and state sales taxes and will provide to FEREDONNA, if required, a certificate of exemption. In any event, the SCHOOL accepts all responsibility for payment of any applicable taxes relating to the Sale.

**VII. ADDITIONAL TERMS** FEREDONNA may elect to assign any or all of this agreement at its option. Jurisdiction and venue governing this agreement shall properly lie in Knox County, Tennessee. Any cost of collection or enforcement of this agreement may be added to the total amount due and become part of any final judgement. This agreement is binding upon acknowledgment and cannot be cancelled by SCHOOL without prior written consent. The SCHOOL hereby agrees to make a good faith effort to sell all Discount Cards ordered by the SCHOOL.

**VIII. ENTIRE AGREEMENT** This agreement constitutes the entire terms and conditions and may only be modified by mutual consent of the parties.
